A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT
BETWEEN JASMINE NAVARRO, a minor by and through her
mother and Guardian Ad Litem NELLY NAVARRO AND THE
CITY OF SAN DIEGO

WHEREAS, on October 29, 2010, JASMINE NAVARRO, a minor by and through her mother and Guardian Ad Litem NELLY NAVARRO filed suit against the City of San Diego [City] and Darron Singleton alleging wrongful death arising from an incident which occurred on February 8, 2010. Plaintiff brought suit in the Superior Court of California, County of San Diego. The suit is entitled *Jasmine Navarro v. City of San Diego, et. al.*: San Diego Superior Court Case No 37-2010-00103338-CU-PA-CTL [Litigation]; and

WHEREAS, in Closed Session on July 29, 2013, the City Council, by the following votes:

Yeas, District(s) 1, 2, 3, 4, 5, 6, 7, 8, 9; Nays, None; Absent, District(s) None; approved the Settlement Agreement; and

WHEREAS, the City Council in closed session on July 29, 2013 authorized settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Council authorizes:

1. The Mayor or his designee to pay the sum of \$425,000.00 from the Water Utility Operating Fund No. 700011, in settlement of each and every claim for damages, interest, costs,


and fees of any type, including attorney fees, against City of San Diego, its agents and employees, and Darron Singleton arising from the personal injury claim of Jasmine Navarro, a minor, San Diego Superior Court Case No. 37-2010-00103338-CU-PA-CTL.

2. The Chief Financial Officer to expend \$425,000.00 from the Water Utility Operating Fund #700011, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. The Comptroller to issue checks in the amounts of: \$181,322.28 made payable to the Law Offices of Jacob Emrani; and \$243,677.72 made payable to Jasmine Navarro and her parent Nelly Navarro.


