A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO RECOGNIZING THE CARMEL MOUNTAIN  
RANCH / SABRE SPRINGS COMMUNITY COMMITTEE  
AND APPROVING THE CARMEL MOUNTAIN RANCH /  
SABRE SPRINGS COMMUNITY COMMITTEE BYLAWS.

WHEREAS, the Sabre Springs Planning Group has had difficulty achieving a quorum in order to conduct business over the past two years; and

WHEREAS, the Carmel Mountain Ranch Community Committee desires to incorporate the Sabre Springs community into its boundaries; and

WHEREAS, the boundary for a community planning group is intended to give a planning group the advisory responsibilities over an area that has been established based on logical, man-made, or geographic boundaries, and is normally based on the boundary of the applicable adopted community plan; and

WHEREAS, pursuant to Council Policy 600-24, the City Council may determine that a boundary other than that of an adopted community plan is the appropriate boundary for a planning group's oversight, and may identify an area different than the adopted community plan; and

WHEREAS, the Carmel Mountain Ranch / Sabre Springs Community Committee's boundary would include the Carmel Mountain Ranch and Sabre Springs community plan areas; and

WHEREAS, on September 11, 2013, the Carmel Mountain Ranch Community Committee voted 8-0-0 to propose new bylaws for the combined Carmel Mountain Ranch / Sabre Springs Community Committee; and

WHEREAS, the proposed new bylaws submitted by Carmel Mountain Ranch Community Committee do not contain any other deviations to Council Policy 600-24; NOW, THEREFORE,


BE IT RESOLVED, by the City Council of the City of San Diego, that the Sabre Springs Planning Group shall no longer be recognized as a community planning group; and

BE IT FURTHER RESOLVED, that the Carmel Mountain Ranch Community Committee shall no longer be recognized as a community planning group; and

BE IT FURTHER RESOLVED, that the Carmel Mountain Ranch / Sabre Springs Community Committee shall be recognized as a community planning group, replacing the Sabre Springs Planning Group and the Carmel Mountain Ranch Community Committee; and

BE IT FURTHER RESOLVED, that the Carmel Mountain Ranch / Sabre Springs Community Committee Bylaws, a copy of which is on file in the Office of the City Clerk as Document No. RR- 308522, is approved.




