DATE OF FINAL PASSAGE OCT 15 2013

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO APPROVE AND ADOPT THE PROPOSED JOINT RESPONSE TO THE 2012/2013 SAN DIEGO GRAND JURY REPORT ENTITLED "REDUCE DEPENDENCE ON IMPORTED WATER."

WHEREAS, on May 15, 2013, the San Diego County Grand Jury filed a report with the Mayor of the City of San Diego and City Council entitled "Reduce Dependence on Imported Water" (Report) and the goal of the Report was to emphasize the need to diversify the local water supply and reduce imported water, while securing the local lifestyle and economy, and

WHEREAS, the Report included five findings and nine recommendations, with two findings and six recommendations directed to both the Mayor and City Council, while the remaining findings and recommendations were directed to the San Diego County Water Authority, and

WHEREAS, under California Penal Code section 933(c), within 90 days after the filing of the Report, each public agency which the Grand Jury reviewed, and about which it issued the Report, must comment to the Presiding Judge of the Superior Court on the findings and recommendations pertaining to matters under the control of the agency; and

WHEREAS, the City requested and was granted a 60-day extension to respond, with the response now due to the Presiding Judge on October 18, 2013; and

WHEREAS, the Independent Budget Analyst (IBA) has proposed and recommends that City Council President Todd Gloria, as interim mayor, and the City Council provide a joint

response to the Report, with the full text of the joint response included as Attachment 1 to IBA report 13-41 which was issued on September 17, 2013; and

WHEREAS, under Charter section 280(a)(1), this Resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and does not affect the administrative service of the City under the control of the Mayor; NOW, THEREFORE,


BE IT RESOLVED by the Council of the City of San Diego as follows:

1. That the City Council approves and adopts as its own the Joint Mayor and Council Response to the 2012/2013 San Diego County Grand Jury Report entitled "Reduce Dependence on Imported Water" as prepared by the IBA with the full text of the joint response included as Attachment 1 to IBA report 13-41 which was issued on September 17, 2013.

2. That the Council President is authorized and directed, on behalf of the San Diego City Council, to execute and deliver the above-described response to the Presiding Judge of the San Diego County Superior Court no later than October 18, 2013.
