A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF A SOLE SOURCE AGREEMENT WITH THE URBAN CORPS OF SAN DIEGO FOR PARK IMPROVEMENTS AT CHICANO PARK.

WHEREAS, in November 2006, the California voters passed the Housing and Emergency Shelter Trust Fund Act of 2006 (Proposition 1C); and

WHEREAS, this Act authorized the California Department of Housing and Community

Development (HCD) to administer \$200 million (over 6 grant cycles) to fund the Housing
Related Parks (HRP) Program; and

WHEREAS, the HRP Program is designed to encourage cities and counties to develop new low income housing by rewarding those jurisdictions with grant funds for the creation, development, or rehabilitation of park and recreation facilities; and

WHEREAS, this award program does not use a competitive process to award funds; all jurisdictions who meet the eligibility requirements will be funded; and

WHEREAS, the HRP funds are awarded on a per-bedroom basis for each affordable, very low and low-income residential units with documented housing starts since the time of the last application cycle; and

WHEREAS, for the previous cycle, 2011, the City was awarded \$1,088,200 in HRP funds, in partnership with the Urban Corps of San Diego, a 501(c)(3) nonprofit organization, to implement park improvements at Chicano Park within the Barrio Logan community; and

WHEREAS, this action will allow the implementation of the 2011 HRP award to proceed in accordance with the funding deadlines and terms contained within the Standard Agreement

(R-2014-205)

No. 11-HRPP-8332 between the City of San Diego and the State of California Department of

Housing and Community Development; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the Council President in his capacity under Charter section 265(i), or his

designee is authorized and directed to execute a sole source agreement with the Urban Corps of

San Diego for an amount not to exceed \$1,088,200, to implement a Housing-Related Parks Grant

for Recreational Improvements to Chicano Park, on file in the office of the City Clerk as

Document No. RR- 308527

2. That the Chief Financial Officer is authorized to expend an amount not to exceed

\$1,088,200 from Grant No. 1000360-2012, Housing Related Parks Grant Round 2, Fund No.

600001, Grant State Fund, for the purpose of executing this agreement.

3. That the Chief Financial Officer is authorized to take all necessary actions in

connection with the 2011 Housing-Related Parks Grant for Recreational Improvements to

Chicano Park.
