(1) small business owner; (2) accounting, financial-lending, legal or economic backgrounds; and

(3) advocates of small business interests with governmental agencies; and

WHEREAS, the Small Business Advisory Board is a Charter section 43 advisory board and the Council is filling the vacancies on the board under the authority granted to it in Charter section 43(c); NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointments and reappointments by the Council of the City of San Diego, in compliance with Charter section 43(c), to serve as members of the Small Business Advisory Board, for the terms expiring as indicated, are made and hereby confirmed:
