A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$31,000 TO THE FOURTH DISTRICT SENIORS RESOURCE CENTER FOR A PUBLIC SERVICES PROJECT, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, Council Policy 100-06, "City Council Funding of Community Projects,
Programs and Services" (CPPS), provides a procedure and uniform requirements for awarding
funds to and contracting with non-profit organizations and public agencies for one-time
community, social, environmental, cultural or recreational needs which serve a lawful public
purpose; and

WHEREAS, the Fourth District Seniors Resource Center has requested funding for a Public Services Project; and

WHEREAS, the requested funding will allow the Fourth District Seniors Resource

Center to provide seniors quality of life activities to help promote self-sufficiency, economic stability, and independent living; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06, "Community Projects, Programs and Services;" and

WHEREAS, Council Districts 3 and 4 recommend an allocation of \$31,000 to the Fourth District Seniors Resource Center for the purposes set forth herein attributed as follows: Council District 3 - \$1,000; and Council District 4 - \$30,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation

described herein is made for a public purpose.

BE IT FURTHER RESOLVED, that the Council hereby waives Council Policy 100-06,

3(g), which provides: "An organization may not apply to receive funding for an event or program

which has already occurred, nor any capital improvement, goods, supplies, materials, or

equipment which have already been purchased."

BE IT FURTHER RESOLVED that the Council President, in his capacity under Charter

section 265(i), or his designee, is authorized and directed to execute, for and on behalf of the

City, an Agreement with the Fourth District Seniors Resource Center in an amount not to exceed

\$31,000 for the project described herein, under terms and conditions set forth in the Agreement

on file in the Office of the City Clerk as Document No. RR-

BE IT FURTHER RESOLVED that the Chief Financial Officer is authorized to expend

an amount not to exceed \$31,000 from the Community Projects, Programs and Services budget

Fund No. 100000, as follows: \$30,000 from Cost Center 1104110004, and \$1,000 from Cost

Center 1103110003, to provide funds for the above-referenced agreement, contingent upon the

Chief Financial Officer first furnishing one or more certificates certifying that the funds

necessary for expenditure are, or will be, on deposit in the City Treasury.
