A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO CONFIRMING THE APPOINTMENT OF  
SCOTT CHADWICK AS CITY MANAGER  
(CHIEF OPERATING OFFICER)

WHEREAS, San Diego Charter section 265(b)(7) gives the Mayor the sole authority to appoint the City Manager, subject to Council confirmation; and

WHEREAS, since about 2006, the working title for the City Manager has been "Chief Operating Officer" and such working title has been reflected in the annual salary ordinance and other City documents; and

WHEREAS, the position of Chief Operating Officer became vacant effective March 1, 2013, due to the resignation of Jay Goldstone; and

WHEREAS, the Interim Chief Operating Officer, Walt Ekard, has announced his resignation effective October 30, 2013; and

WHEREAS, the Council President, in his capacity under Charter section 265(i) during the vacancy in the office of Mayor, has appointed Scott Chadwick to serve as Chief Operating Officer, subject to Council confirmation; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the appointment by the Council President, in his capacity under Charter section 265(i), of Scott Chadwick as City Manager (Chief Operating Officer) for the City of San Diego, effective on October 31, 2013, is hereby confirmed.


