WHEREAS, the City of San Diego (City) is considering improvements to the Euclid Avenue interchange with State Route 94 to enhance safety features through this corridor; and

WHEREAS, a Traffic Study/Report, in coordination with Caltrans, has been developed to determine the level of design documentation required; and

WHEREAS, this planning phase was completed at the end of 2012 and provided recommendations that would consider the optimization of the level of service for both Euclid Avenue and SR 94; and

WHEREAS, the project is ready to proceed with preliminary engineering and the development of documentation needed to move the project forward into design; and

WHEREAS, this action would provide funding for the development of plans, specifications, and project cost estimates, while also consolidating project funds into one fund, eliminating duplicate project accounts and minimizing duplicate efforts; NOW, THEREFORE,

BE IF RESOLVED, that the Chief Financial Officer is authorized to transfer appropriations and expenditures in an amount not to exceed \$425,000 from CIP S-11046, SR94/Euclid Avenue, to CIP S-14009, SR94/Euclid Avenue Interchange – Phase 2, within Fund 400174, Transnet Extension RTCIP; and

BE IF FURTHER RESOLVED, the Chief Financial Officer is authorized to close CIP S-11046, SR94/Euclid Avenue Interchange; and

BE IT FURTHER RESOLVED, that this activity is a fiscal action to create funding mechanisms and is not a project and is therefore exempt from CEQA pursuant to State CEQA Guidelines, section 15060(c)(3) and section 15378(b)(4).
