DATE OF FINAL PASSAGE NOV 21 2013

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT AUTHORIZATION TO FUND LIGHTING IMPROVEMENTS AT THE WILLIE HENDERSON SPORTS COMPLEX IS CATEGORICALLY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT PURSUANT TO CEQA GUIDELINES SECTIONS 15301 AND 15303.

WHEREAS, the California Environmental Quality Act (CEQA) (Public Resources Code section 21000 et seq.), section 21084, states that the CEQA Guidelines thereto (California Code of Regulations, Title 14, Chapter 3, Section 15000 et seq.) shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to that authority, CEQA Guidelines sections 15300-15333 list the categorical exemptions promulgated by the California Office of Planning and Research and adopted by the Secretary of the California Natural Resources Agency for those classes of Projects which have been determined not to have a significant effect on the environment; and


WHEREAS, the Development Services Department has established that the authorization to fund improvements to the security lighting at the Willie Henderson Sports Complex is categorically exempt from CEQA pursuant to CEQA Guidelines sections 15301, and 15303, and that no exception to the exemptions, as set forth in CEQA Guidelines section 15300.2, apply to the Project; and

WHEREAS, the Council held a duly-noticed public meeting and considered the written record for the Requested Authorization as well as public comment; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, using its independent judgment, has considered the written record and public comment for the City's request to authorize funding for improvements to the security lighting at the Willie Henderson Sports Complex, and has determined that said activity is categorically exempt from CEQA pursuant to CEQA Guidelines section 15301, and 15303 and that an exception to the exemption does not apply under CEQA Guidelines section 15300.2.


