

RESOLUTION NUMBER R- 308576DATE OF FINAL PASSAGE NOV 20 2013

A RESOLUTION FOR THE COUNCIL OF THE CITY OF SAN DIEGO TO ACCEPT THE SAN DIEGO POLICE DEPARTMENT'S UPDATED FIVE-YEAR PLAN, DATED OCTOBER 21, 2013.

WHEREAS, the City of San Diego Police Department (SDPD) developed a Five-Year Plan to begin the process of rebuilding the Police Department in areas impacted most by past budget reductions; and

WHEREAS, the SDPD initially presented its Five-Year Plan to the Committee on Public Safety and Neighborhood Services (Committee) on July 18, 2012; and

WHEREAS, the SDPD prepared a Five-Year Plan Update and presented that updated plan to the Committee on October 30, 2013, in Report No. 13-083; and

WHEREAS, the Report is on file with the Office of the City Clerk under Document No. RR 308576; and

WHEREAS, the Report requests that sworn staffing levels be restored to FY 2009 budgeted levels; high priority civilian positions be restored; necessary operational equipment (including a new Computer Aided Dispatch system) be funded; and that facility maintenance needs be funded; and

WHEREAS, the Committee accepted the Report and requested the Mayor to fund an independent compensation study for the Police Department as part of an effort to see how SDPD's compensation compares to other jurisdictions; NOW, THEREFORE,

BE IT RESOLVED, that the Council of the City of San Diego recommends that the Police Department Five-Year Plan Update be used as the City of San Diego's framework to

rebuild the Police Department in areas impacted most by past budget reductions, and accepts the Plan Update to rebuild the Department.
