A RESOLUTION OF THE COUNCIL OF THE CITY OF

WHEREAS, the Council President, in his capacity under Charter section 265(i) during the Mayoral vacancy, has appointed Mary Lewis to serve as the Chief Financial Officer; and

WHEREAS, the Council President has requested Council confirmation of his appointment of Mary Lewis as Chief Financial Officer, effective December 2, 2013; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the appointment by the Council President, in his capacity under Charter section 265(i), of Mary Lewis as Chief Financial Officer for the City of San Diego, effective on December 2, 2013, is hereby confirmed.
