DATE OF FINAL PASSAGE DEC 09 2013

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING WATER RATE INCREASES
IN ACCORDANCE WITH PROPOSITION 218.

WHEREAS, the Public Utilities Department prepared and submitted to the Council its Report No. 13-081, indicating that water rate increases were proposed to become effective on January 1, 2014 and January 1, 2015; and

WHEREAS, on July 31, 2013, the Natural Resources & Culture Committee approved the proposed increases as detailed in the 2013 Water Cost of Service Study and recommended that the matter be forwarded to the Council for approval; and

WHEREAS, on September 10, 2013 by Resolution No. R-308430, the Council considered the matter and authorized the issuance of a Notice of the proposed water rate increases to all affected customers and authorized a public hearing for November 21, 2013 to approve the proposed increases; and

WHEREAS, in accordance with Article XIID, section 6 of the California Constitution [Proposition 218], the City noticed a public hearing for November 21, 2013 and mailed a Notice of the proposed water rate adjustments to all City water customers, a copy of which Notice is on file with the City Clerk as Document No. RR- 308589; and

WHEREAS, the Proposition 218 Notice was mailed on or before October 4, 2013, as required to be at least 45 days prior to the noticed public hearing, and the City did not receive written protests from a majority of the affected water customers by the close of the public

hearing conducted in accordance with Proposition 218 and the procedures previously adopted by the Council in Resolution No. R-302245; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Council authorizes the proposed water rate adjustments set out in Report to City Council No. 13-081, increasing water rate system revenue by 7.25% effective January 1, 2014, and 7.5% effective January 1, 2015.

2. That the Council authorizes the proposed water base fee and commodity charge adjustments, consistent with the recommendations of the 2013 Water Cost of Service Study [COSS], to reflect a proportionate share of revenue between user classifications.


3. That the Council authorizes the proposed changes to the Single Family Residential Customers' Tier Structure based on the recommendations of the COSS.

4. That the Council authorizes the proposed adjustments to the monthly Private Fire Service Charge based on the recommendations of the COSS.

5. That the Council receives the Report to City Council No. 13-081, dated November 8, 2013 and on file with the City Clerk as Document No. RR- 308589.




