A RESOLUTION OF THE COUNCIL OF THE CITY
OF SAN DIEGO CONFIRMING APPOINTMENTS TO
THE COMMISSION ON GANG PREVENTION AND
INTERVENTION

WHEREAS, the City of San Diego Commission on Gang Prevention and Intervention (Gang Commission) is established in the San Diego Municipal Code, Chapter 2, Article 6, Division 19 to serve as an advisory body to the Mayor and City Council on policy issues relating to gang prevention and intervention; and

WHEREAS, the Gang Commission was established to develop a more strategic, coordinated and collaborative effort between the City, law enforcement agencies, social service providers and the general public, with a goal of significantly curtailing gang involvement and its negative impact in the City of San Diego; and

WHEREAS, the Municipal Code provides that the Gang Commission shall consist of 20 members appointed by the Mayor and confirmed by the City Council; and

WHEREAS, the members shall be appointed by the Mayor as follows: (1) nine members, one each from a list of at least two nominations submitted by each Councilmember to represent his or her district; and (2) one member from a community organization working on gang issues; (3) one member from the field of public health; (4) one member from the field of social services; and (5) one member who shall be a reformed ex-gang member; and

WHEREAS, the remaining seven members are officeholders for whom no appointment is required; and

WHEREAS, except for officeholders, members shall serve two-year terms and each member shall serve until a successor is appointed and confirmed; and

WHEREAS, the Commission is a Charter section 43 advisory board and the Council is filling vacancies on the Commission under the authority granted to it in Charter section 43(c);

NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, that the following appointments and reappointments by the Council of the City of San Diego, in compliance with San Diego Charter section 43(c), to serve as members of the Commission on Gang Prevention and Intervention, for terms expiring as indicated, are made and hereby confirmed:


