DATE OF FINAL PASSAGE DEC 26 2013

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ADOPTING THE CITY OF SAN DIEGO
BICYCLE MASTER PLAN UPDATE.

WHEREAS, on May 28, 2002, the City Council of the City of San Diego approved Resolution No. R-296581, adopting the City of San Diego's Bicycle Master Plan; and

WHEREAS, the City of San Diego Bicycle Master Plan Update provides direction for expanding the existing bikeway network, connecting gaps, providing for improved local and regional connectivity, and encouraging bicycling as a transportation mode; and


WHEREAS, on July 25, 2013, the Planning Commission of the City of San Diego considered the City of San Diego Bicycle Master Plan Update, and pursuant to Planning Commission Resolution No. 4535-PC, the Planning Commission voted to recommend City Council adopt the City of San Diego Bicycle Master Plan Update, certify the Environmental Impact Report No. 290781 and adopt the Findings, Statement of Overriding Considerations and Mitigation, Monitoring and Reporting Program No. 290781. In addition, the Planning Commission recommended that the Findings of Fact and Statement of Overriding Considerations be revised to include additional language to balance vehicular level of service goals with bicycle network expansion goals, and include complete streets language in the project benefits; and

WHEREAS, on December 9, 2013, the City Council of the City of San Diego held a public hearing for the purpose of considering the adoption of the City of San Diego Bicycle Master Plan Update; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council adopts the City of San Diego Bicycle Master Plan Update as amended to remove the Rose Canyon and Roselle Canyon segments, a copy of which is on file in the office of the City Clerk as Document No. RR- 308597 .

BE IT FURTHER RESOLVED, that the City Attorney's Office and staff are directed to come back within 30 days with appropriate language regarding a proposed bicycle advisory committee.




