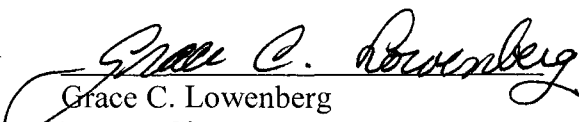
A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO REGARDING ENVIRONMENTAL REVIEW OF CHANGE ORDER NO. 1 TO THE AS-NEEDED CONSTRUCTION CONTRACT WITH SCS FIELD SERVICES FOR EMERGENCY DRILLING SERVICES AT VARIOUS CITY LANDFILLS.

WHEREAS, the impacts associated with Change Order No.1 to the as-needed construction contract with SCS Field Services for Emergency Drilling Services at Various City Landfills were considered in the 2007 Environmental Impact Report, project no. 122833, schedule no. 2006051004, for the Miramar Landfill Height Increase Project and were found not to be significant; and

WHEREAS, that Environmental Impact Report, which was reviewed and considered by the Planning Director and certified on October 3, 2007, adequately addresses the work in connection with Change Order No. 1 and there is no change in circumstance, additional information, or project changes which warrant additional environmental review; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the above activity is not a separate project under the California Environmental Quality Act [CEQA] pursuant to CEQA Guidelines section 15162 because this activity is a subsequent discretionary approval of a project which was adequately addressed in a 2007 Environmental Impact Report, project number 122833, schedule number 2006051004, which was reviewed and considered by the Planning Director and certified on October 3, 2007, and there is no change in circumstance, additional information, or project changes to warrant additional environmental review.
