A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF AMENDMENT NO. 1 TO THE COOPERATIVE AGREEMENT WITH CALTRANS FOR THE HILLERY DRIVE IMPROVEMENTS PROJECT.

WHEREAS, in 2011 the City of San Diego entered into a cooperative agreement with Caltrans to design and construct the Hillery Drive Improvements Project, that provided the widening of Hillery Drive between Black Mountain Road and Westview Parkway and traffic calming on adjacent streets; and

WHEREAS, in accordance with the agreement, Caltrans has provided the City with \$2,500,000 in exchange for completion of the project by December 31, 2013 with additional time being added so that the project completion will coincide with the opening of the direct access ramps; and

WHEREAS, Amendment No. 1 to the Cooperative Agreement with Caltrans will extend the expiration date from December 31, 2013 to June 30, 2014 at no additional cost to the project; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

1. That the Council President or his designee, in his capacity under Charter section 265(i), is hereby authorized to execute, for and on behalf of the City, Amendment No. 1 to the Cooperative Agreement with Caltrans, on file in the office of the City Clerk as Document No.

308608, for the purposes of providing additional time for design and construction of CIP S-11064, Hillery Drive Improvements Project at no additional cost to the City.

- 2. Stating for the record that the Final Mitigated Negative Declaration No. 222562 (Hillery Drive Road Widening), dated March 27, 2013 has been reviewed and considered prior to approving the project;
