A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO RATIFYING THE SOLE SOURCE CONTRACT  
AWARD TO CASS CONSTRUCTION FOR THE UNIVERSITY  
CITY SINKHOLE EMERGENCY REPAIRS PROJECT.

WHEREAS, an emergency situation affecting public health or safety arose on October 6, 2011, when a collapsed 30-inch corrugated metal storm-drain pipe created a sinkhole measuring 50-feet long by 30-feet wide and 5-feet deep in Campus Point Drive in the University City neighborhood; and

WHEREAS, Cass Construction performed work to remedy the aforementioned emergency pursuant to a sole source contract at a cost of \$498,271.80; and

WHEREAS, section 22.3108(a) of the San Diego Municipal Code requires that the award of an emergency sole source contract be ratified by a two-thirds vote of the Council of the City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the sole source contract awarded to Cass Construction for construction services to remedy the sinkhole on Campus Point Drive in University City, in the amount of \$498,271.80, a copy of which contract is on file with the Office of the City Clerk as Document No. RR- 308609, is hereby ratified.

2. That the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$498,271.80 from CIP A-CA.00001, Drainage Projects (B-12039, University City Sinkhole Emergency Repairs).
