A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO RATIFYING THE SOLE SOURCE CONTRACT AWARD TO HAZARD CONSTRUCTION FOR THE QUALCOMM STADIUM EMERGENCY CONCRETE REPAIRS PROJECT.

WHEREAS, an emergency situation affecting public health or safety was created by spalling in the concrete at Qualcomm Stadium, which led to loose concrete that fell from overhead balconies into the Plaza and other seating areas; and

WHEREAS, Hazard Construction is performing work to remedy the aforementioned emergency pursuant to a sole source contract at a cost of \$673,000.00; and

WHEREAS, section 22.3108(a) of the San Diego Municipal Code requires that the award of an emergency sole source contract be ratified by a two-thirds vote of the Council of the City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

- 1. That the sole source contract awarded to Hazard Construction for construction services to remedy the spalling and deteriorated concrete at Qualcomm Stadium, in the amount of \$673,000.00, a copy of which contract is on file with the Office of the City Clerk as Document No. RR-____308611, is hereby ratified.
- 2. That the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$673,000.00 from CIP A-BG.00001, Qualcomm Stadium (B-13091, Qualcomm Stadium Emergency Concrete Repairs), for the aforementioned contract, provided

that the Chief Financial Officer first furnishes one or more certificates demonstrating that the funds necessary for expenditure are, or will be, on deposit with the City Treasury.
