DATE OF FINAL PASSAGE DEC 24 2013

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT THE REQUESTED AUTHORIZATION FOR THE ACCEPTANCE OF A GRANT OF EASEMENT FROM THE NAVY FOR A 25-YEAR WATER EASEMENT AND EXPENDITURE OF \$741,000 AS COMPENSATION FOR THE EASEMENT, IS CATEGORICALLY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT PURSUANT TO CEQA GUIDELINES SECTION 15301.

WHEREAS, the California Environmental Quality Act (CEQA), Public Resources Code section 21084, states that the CEQA Guidelines shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to that authority, CEQA Guidelines sections 15300-15333 list the categorical exemptions promulgated by the California Office of Planning and Research for those classes of projects which have been determined not to have a significant effect on the environment; and

WHEREAS, the City of San Diego (City) requests authorization to accept a Grant of Easement from the Navy and expend \$741,000 as compensation for the easement in order to allow the City to continue utilizing an easement that has been used for water utility purposes since 1961; and


WHEREAS, the Development Services Department has determined that the City's activity is categorically exempt from CEQA pursuant to CEQA Guidelines section 15301; and

WHEREAS, the City Council held a duly noticed public meeting and considered the written record for the City's activity as well as public comment; NOW, THEREFORE,

BE IT RESOLVED, that the Council of the City of San Diego, using its independent judgment, has considered the written record and public comment for the City's requested authorization to accept a Grant of Easement from the Navy and expend \$741,000 as compensation for the easement, and has determined that said activity is categorically exempt from CEQA pursuant to CEQA Guidelines section 15301, and that an exception to the exemption as set forth in CEQA Guidelines section 15300.2 does not apply.
