- 1. That the Council President, in his capacity under Charter section 265(i), or his designee, is authorized and directed to sign the settlement agreement pertaining to this lawsuit.
- 2. That the sum of sixty thousand dollars (\$60,000) is to be paid from Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs and fees of any type, including attorney fees, against the City, its agents and employees, arising from the Litigation.
