BE IT FURTHER RESOLVED, that the installation of necessary signs and marking for such angle parking is authorized, and the regulations shall become effective on installation of the signs.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$2,800 from the General Fund, Fund 100000, 2116 Transportation & Storm Water operating budget for the installation of angle parking on G Street between 22nd

Street and 25th Street contingent upon the City Comptroller first certifying that the funds are, or will be on deposit with the City Treasurer.
