DATE OF FINAL PASSAGE DEC 24 2013

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING EXPANSION OF THE PERMIT
PARKING AREA "E" IN THE CLAIREMONT MESA
COMMUNITY PLAN AREA.

WHEREAS, Residential Permit Parking Area "E" in the Clairemont Mesa area was established in 2003; and

WHEREAS, the City Council approved an expansion and a reduction to the Area "E" Permit Parking Area on July 5, 2006, by Resolution Nos. R-301595 and R-301596; and

WHEREAS, parking usage and occupancy studies performed in recent years and corroborated by field inspections performed by Traffic Engineering staff have determined that the subject area is severely impacted by all-day commuter parking; and


WHEREAS, a petition representing a majority of affected residences has provided support for an expansion of the Permit Parking Area "E"; and

WHEREAS, a public hearing was held on June 25, 2013, and the residents present voiced full support for the proposed expansion; and

BE IT RESOLVED, by the Council of the City of San Diego, that pursuant to authority conferred by and in accordance with the provisions of San Diego Municipal Code section 86.2005(b), expansion to existing Residential Permit Parking Area "E" includes the properties on Armstrong Street, Beagle Street, Beagle Court, Arillo Street, Apollo Street, Ames Street, Ben Street, Argyle Street, and Baltic Street, as listed in the Attachment 1.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is authorized to be made on said street, and the regulations hereinabove imposed shall become effective upon the installation of such signs.
