A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CONFIRMING APPOINTMENTS TO THE ETHICS COMMISSION

WHEREAS, the Ethics Commission (Commission) is established in the San Diego Municipal Code under Chapter 2, Article 6, Division 4 to monitor, administer, and enforce the City's governmental ethics laws, and other duties set forth in that Division; and

WHEREAS, the Municipal Code provides that the Commission shall consist of seven members appointed by the Mayor from a pool of nominees submitted by the members of the City Council and City Attorney, and subject to confirmation by a majority of the City Council; and

WHEREAS, the Municipal Code provides that the members shall serve staggered fouryear terms; each member shall serve until a successor is duly appointed and confirmed; and all terms must have expiration dates of June 30; and

WHEREAS, the Municipal Code provides that the Commission shall reflect the diversity of the City, and include: (1) at least one person who has been a candidate for an elective governmental office, has worked as a treasurer or other high-level position in a campaign for elective governmental office, or has held an elective governmental office; and (2) at least two attorneys in good standing with the California Bar Association; and

WHEREAS, the ordinance requires that no more than three members of the Commission shall be registered with the same political party; and

WHEREAS, the Ethics Commission is a Charter section 41 commission and the Council is filling vacancies on the board under the authority granted to it in Charter section 41, as the

Mayor did not make appointments within forty-five days of vacancies on the panel; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointments by the Council of the City of San Diego, in compliance with San Diego Charter section 41, to serve as members of the Ethics Commission, for terms expiring as indicated, are made and hereby confirmed:
