A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT THE APPROVAL OF THE CONTRACT WITH WEST COAST ARBORIST, INC. AND RELATED EXPENDITURES FOR TREE SERVICE ACTIVITIES WITHIN THE PARK AND RECREATION MAINTENANCE ASSESSMENT DISTRICTS IS CATEGORICALLY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT PURSUANT TO CEQA GUIDELINES SECTION 15301.

WHEREAS, the City of San Diego's Park and Recreation Department currently administers 50 Maintenance Assessment Districts located throughout the City (collectively, the Districts); and

WHEREAS, service requirements within the Districts include maintenance of landscape and hardscape medians, parkways, greenbelts, parks, open space, as well as enhanced services including landscaping on a median, enhanced open space, and focal landscaping; and

WHEREAS, all tree service activities in the Districts are provided by a landscape contractor; and

WHEREAS, following a competitive selection and procurement process, the City selected West Coast Arborist, Inc. as the lowest and most responsive proposer, and the City Council authorized a contract with West Coast Arborist, Inc. for tree service activities within the Districts (Project); and

WHEREAS, the California Environmental Quality Act (CEQA) (Public Resources Code section 21000 et seq.), section 21084, states that the CEQA Guidelines thereto (California Code of Regulations, Title 14, Chapter 3, Section 15000 et seq.) shall list those classes of projects

which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to that authority, CEQA Guidelines sections 15300-15333 list the categorical exemptions promulgated by the California Office of Planning and Research and adopted by the Secretary of the California Natural Resources Agency for those classes of projects which have been determined not to have a significant effect on the environment; and

WHEREAS, the Development Services Department has established that the Project is categorically exempt from CEQA pursuant to CEQA Guidelines section 15301 related to maintenance of existing facilities and that no exception to the exemption, as set forth in CEQA Guidelines section 15300.2, applies to the Project; and

WHEREAS, the City Council has considered the potential environmental effects of the Project; and

WHEREAS, on December 17, 2013, the City Council held a duly noticed public meeting and considered the written record for the Project as well as public comment; and

WHEREAS, the City Council, using its independent judgment, has determined that the Project will not have a significant effect on the environment because the tree service activities in the Districts merely include care and cleaning of existing street medians, parkway landscaping, sidewalks, curbs and gutters, landscaped slopes, greenbelts, and open space areas; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The Council has determined that the Project is categorically exempt from CEQA pursuant to CEQA Guidelines section 15301.
