DATE OF FINAL PASSAGE DEC 17 2013

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO REGARDING A SPECIAL RUN-OFF ELECTION TO BE HELD IN THE CITY OF SAN DIEGO ON TUESDAY, FEBRUARY 11, 2014, FOR THE PURPOSE OF ELECTING A MAYOR FOR THE CITY OF SAN DIEGO.

WHEREAS, at a meeting on December 17, 2013, the City Council passed Ordinance No. O-20334 (N.S.), calling a Special Run-off Election in the City of San Diego on Tuesday, February 11, 2014, for the purpose of electing a Mayor to fill the remainder of the term previously held by Bob Filner, who resigned from the office; and

WHEREAS, it is desirable that the Board of Supervisors of the County of San Diego be authorized to canvass the returns of the Special Run-off Election; and

WHEREAS, actions related to calling a Special Run-off Election for the office of Mayor are mandated by San Diego Charter section 265(e), and therefore, are not subject to veto; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The Board of Supervisors of the County of San Diego is hereby authorized to canvass the returns of the Special Run-off Election and is requested to conduct the election.
2. The Board of Supervisors of the County of San Diego is hereby requested to authorize and direct the Registrar of Voters of the County of San Diego to perform the following:
  - (a) Furnish a tabulation of the number of registered voters in the City by precinct;
  - (b) Examine and verify the signatures on nominating petitions;

- (c) Provide election materials in languages other than English in accordance with federal law;
- (d) Canvass the returns of the election, including absent voter ballots;
- (e) Furnish a tabulation of the number of votes given in the City by precinct;  
and
- (f) Complete any and all tasks related to the legal conduct of this election as required of the City Clerk upon the request of the City Clerk or the City Council.


5. The City Clerk of the City of San Diego is hereby directed to file a certified copy of this Resolution with the Board of Supervisors and Registrar of Voters of the County of San Diego.

BE IT FURTHER RESOLVED, that the City Comptroller is authorized to reimburse the County of San Diego for the actual and direct cost of the services performed by the Registrar of Voters for the City of San Diego in connection with the election services herein described, provided that the City Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the City of San Diego agrees to indemnify and to save free and harmless the County, its officers, agents, and employees from expense or liability,

including reasonable attorney fees, as the result of an election contest initiated pursuant to the California Elections Code sections 16000 through 16900.
