DATE OF FINAL PASSAGE JAN 30 2014

AN ORDINANCE OF THE COUNCIL OF THE CITY OF
SAN DIEGO AMENDING CHAPTER 8, ARTICLE 6,
DIVISION 1, OF THE SAN DIEGO MUNICIPAL CODE BY
AMENDING SECTION 86.0108, RELATING TO GENERAL
PARKING REGULATIONS.

WHEREAS, the ownership of electric vehicles has expanded substantially in the State of
California; and

WHEREAS, electric vehicles produce less greenhouse gasses than equivalently sized gas
combustion vehicles; and

WHEREAS, the City of San Diego now desires to create designated parking spaces for
use by plug-in electric vehicles; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That Chapter 8, Article 6, Division 1, of the San Diego Municipal Code be
amended by amending section 86.0108, to read as follows:

§86.0108 Parking, Standing, Loading Zones, Street Sweeping Zones

- (a) The City Manager is hereby authorized to determine the location of
Loading Zones, Passenger Loading Zones, Bus Loading Zones, Taxi
Zones, prohibited Standing or Parking Zones, Time-Limited Parking
Zones of 30 Minutes or Less, Time-Limited Parking Zones for Ballpark
Event Residential Permit Parking Districts, Safety Zones, Disabled
Persons Parking Zones, Alley Parking Zones, Consular Parking Zones,
Street Sweeping Zones, Pedicab Resting Zones, Pedicab Parking Zones,


Car Share Parking Zones, and Electric Vehicle Parking Zones. Such zones shall be effective when appropriate signs or curb markings giving notice thereof are erected upon such zones.

- (b) As used in this section, "Electric Vehicle" shall mean a vehicle that uses one or more electric motors for propulsion and receives electricity from a source external to the vehicle.

Section 2. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.


