AN ORDINANCE OF THE CITY OF SAN DIEGO SUBMITTING TO THE QUALIFIED VOTERS OF THE CITY OF SAN DIEGO, FOR THEIR APPROVAL OR REJECTION AT THE MUNICIPAL SPECIAL ELECTION, CONSOLIDATED WITH THE CALIFORNIA STATE PRIMARY ELECTION TO BE HELD ON JUNE 3, 2014, RESOLUTION NO. R-308445, "A RESOLUTION APPROVING AN AMENDMENT TO THE BARRIO LOGAN COMMUNITY PLAN AND THE GENERAL PLAN AND TO THE LOCAL COASTAL PROGRAM AND IMPLEMENTATION PLAN TO EFFECT A COMPREHENSIVE UPDATE TO THE BARRIO LOGAN COMMUNITY PLAN."

WHEREAS, on September 17, 2013, a resolution approving amendments to the Barrio Logan Community Plan, on file in the Office of the City Clerk as Resolution No. R-308445 (Resolution), was adopted by the Council of the City of San Diego (Council); and

WHEREAS, on October 2, 2013, the Council President, acting with limited mayoral authority pursuant to San Diego Charter (Charter) section 265(i), returned the Resolution to the City Clerk unsigned, resulting in approval of the Resolution pursuant to Charter sections 265(i) and 280; and

WHEREAS, pursuant to Charter sections 265(i) and 295, the Resolution's date of final passage was October 2, 2013; and

WHEREAS, on October 31, 2013, an authorized representative of proponent, Port of San Diego Ship Repair Association, through the committee Protect Our Jobs Coalition, submitted a referendary petition against the Resolution to the City Clerk, and on that same day, the City Clerk accepted the referendary petition as filed, thereby suspending the Resolution; and

WHEREAS, the City Clerk submitted the referendary petition to the San Diego County Registrar of Voters (Registrar of Voters) for signature verification; and

WHEREAS, the Registrar of Voters conducted a legally required verification and found the petition to contain the valid signatures of more than five percent of the City's registered voters at the last general election, sufficient to qualify the measure for direct submission to the voters as required by Charter section 23; and

WHEREAS, on November 19, 2013, the City Clerk certified that the referendary petition was sufficient and qualified for submittal to the voters; and

WHEREAS, on December 10, 2013, in compliance with San Diego Municipal Code (Municipal Code) section 27.1125, the City Clerk presented the petition and a certification of the sufficiency of its signatures to the City Council; and

WHEREAS, in compliance with Charter section 23 and Municipal Code section 27.1131, the City Council shall, within ten business days of the date of the Clerk's presentation, reconsider the legislative act; and

WHEREAS, Municipal Code sections 27.1131 and 27.1132 require the City Council to reconsider the Resolution and either: (1) grant the referendary petition to rescind the Resolution, or (2) adopt a resolution of intention to submit the matter to the voters at a special election, and direct the City Attorney to prepare an ordinance calling a special election to place the matter on the ballot; and

WHEREAS, a special election for a referendum may be consolidated with the next Citywide Primary Election or Citywide General Election at which the matter can be placed on the ballot, or a separate special election may be called for the purpose of voting on the matter; and

WHEREAS, on December 17, 2013, the Council reconsidered the Resolution in light of the referendary petition; and

WHEREAS, the Council decided not to rescind the Resolution, but to submit to the electorate, at a special election to be held at the same time as the next Citywide Primary Election in June 2014, the referendary petition against Resolution No. R-308445; and

WHEREAS, by Ordinance No. O- **20345**, introduced and adopted on January 27, 2014, the Council has called a Municipal Special Election, to be consolidated with the California State Primary Election to be held June 3, 2014, for the purpose of submitting to the qualified voters of the City one or more ballot propositions; and

WHEREAS, in compliance with the Municipal Code, state law and the Council's resolution directing placement of the resolution on the ballot, the City Attorney has prepared this ordinance to submit to the electorate, for approval or rejection, Resolution No. R-308445; and

WHEREAS, pursuant to Charter section 295(b), the Council's placement of the proposition on the ballot at a Municipal Special Election, after consideration of a related referendary petition, is not subject to veto; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That one proposition is hereby submitted to the qualified voters at the Municipal Special Election to be held on June 3, 2014, and consolidated with the California State Primary Election to be held on the same date, with the proposition to read as follows:

## **PROPOSITION**

(See Attachment 1 to this Ordinance for the text of the Proposition.)

## **END OF PROPOSITION**

Section 2. The proposition shall be presented and printed upon the ballot and submitted to the voters in the manner and form set out in Section 3 of this ordinance.

Section 3. On the ballot to be used at this Municipal Special Election, in addition to any other matters required by law, there shall be printed substantially the following:

OPOSITION REFERENDUM OF RESOLUTION LATED TO BARRIO LOGAN COMMUNITY PLAN DATE. Shall Resolution No. R-308445, which provides for a prehensive update to the Barrio Logan Community Plan, be	YES	
approved?	NO	

Section 4. An appropriate mark placed in the voting square after the word "Yes" shall be counted in favor of the adoption of this proposition. An appropriate mark placed in the voting square after the word "No" shall be counted against the adoption of the proposition.

Section 5. Passage of this proposition requires the affirmative vote of a majority of those qualified electors voting on the matter at the Municipal Special Election.

Section 6. The City Clerk shall cause this ordinance or a digest of this ordinance to be published once in the official newspaper following this ordinance's adoption by the City Council.

Section 7. Pursuant to San Diego Municipal Code section 27.0402, this measure will be available for public examination for no fewer than ten calendar days prior to being submitted for printing in the sample ballot. During the examination period, any voter registered in the City may seek a writ of mandate or an injunction requiring any or all of the measure to be amended or deleted. The examination period will end on the day that is 75 days prior to the date set for the election. The Clerk shall post notice of the specific dates that the examination period will run.

Section 8. A full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been available to the City Council and the public prior to the day of its

passage.

Section 9. Pursuant to sections 295(b) and 295(d) of the Charter of the City of

San Diego, this ordinance shall take effect on the date of passage by the City Council, which is

deemed the date of its final passage.
