AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF THE SECOND AMENDMENT TO THE AGREEMENT WITH RICK ENGINEERING COMPANY FOR THE STATE ROUTE 163 AND CLAIREMONT MESA INTERCHANGE PROJECT-PHASE 2.

WHEREAS, in 2008, the City of San Diego (City), in partnership with Caltrans, completed construction of Phase I of the State Route 163 and Clairemont Mesa Boulevard Interchange Project (Project), which widened the bridge overcrossing at the Project location and realigned the eastern ramps; and

WHEREAS, in 2012, the City Council authorized the First Amendment to the Agreement with Rick Engineering for out of scope work, which included but was not limited to, revisions to the construction staging plans as recommended by the project team; and

WHEREAS, the proposed Second Amendment to the Agreement with Rick Engineering Company is required to provide design plans, structural calculations, and geotechnical recommendations for a proposed Type 2 Retaining Wall and to revise the layout, construction details, construction staging, signage, pavement delineation, traffic electrical and quantity plans to conform to the new Caltrans District 11 plans preparation guidelines and requirements; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Council President or his designee, in his capacity under Charter section 265(i), is hereby authorized and empowered to execute, for and on behalf of the City, the Second Amendment to the Agreement with Rick Engineering Company for the purpose of

completing the second phase of the State Route 163 and Clairemont Mesa Boulevard Interchange under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. OO- 20355

Section 2. That the expenditure of an amount not to exceed \$107,060 from CIP S-00905, State Route 163 and Clairemont Mesa Boulevard Interchange, Fund 400169, Transnet, is authorized for the purpose of providing funds for the above-referenced Project.

Section 3. That the Chief Financial Officer, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

Section 4. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 5. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
