AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR, OR HIS DESIGNEE, TO EXECUTE A SECOND AMENDMENT TO AGREEMENT (RICHARD HENRY DANA CENTER - DANA MIDDLE SCHOOL).

WHEREAS, the City of San Diego (City) and the San Diego Unified School District (District) have cooperated on joint use of recreational facilities since 1948; and

WHEREAS, on February 22, 1994, the City and District entered into an "Agreement for the Construction, Operation, Maintenance, and Lease of Turfed Field and Recreation Facilities at Richard Henry Dana Center" (Agreement); and

WHEREAS, the Agreement was authorized pursuant to Ordinance No. O-18041; and WHEREAS, on February 1, 1999 the City and District entered into a "First Amendment to Agreement (Richard Henry Dana Center)" (First Amendment) to revise the scheduled use of joint-use facilities and the maintenance obligations of both the City and District; and

WHEREAS, the First Amendment was authorized pursuant to Ordinance No. O-18623; and

WHEREAS, the City and District now desire to enter into a "Second Amendment to Agreement (Richard Henry Dana Center - Dana Middle School)" to remove the 3.5 acre baseball field from the Agreement, thereby providing full control of the baseball field to the District prior to the District initiating field improvements; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized and directed to execute, a Second Amendment to Agreement (Richard Henry Dana Center - Dana Middle School) on file with the City Clerk as Document No. OO- 20370.

Section 2. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the City Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
