AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF A NINTH AMENDMENT TO THE AGREEMENT WITH SAN DIEGO METROPOLITAN TRANSIT SYSTER FOR THE ADMINISTRATION OF THE TAXICAB PROGRAM.

WHEREAS, the City and MTS now desire to enter into a Ninth Amendment for Administration of Taxicab and Other For-Hire Vehicle Regulation; NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is hereby authorized to execute, for and on behalf of said City, the Ninth Amendment to the Agreement with Metropolitan Transit System (MTS) for administration of taxicab and other for-hire vehicle regulations, the under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No.

Section 2. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
