DATE OF FINAL PASSAGE JUN 23 2014

AN ORDINANCE OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE EXECUTION OF A NINTH
AMENDMENT TO THE AGREEMENT WITH SAN DIEGO
METROPOLITAN TRANSIT SYSTER FOR THE
ADMINISTRATION OF THE TAXICAB PROGRAM.

WHEREAS, the Metropolitan Transit System (MTS) has administered and regulated taxicabs and other for-hire vehicles on behalf of the City since June 28, 1988 (City Clerk Document No. RR-271306); and

WHERESAS, the City and MTS have executed eight subsequent amendments to this agreement, First Amendment on December 12, 1988 (City Clerk Document No. RR-272517), Second Amendment on November 29, 1993 (City Clerk Document No. RR-283074), Third Amendment on June 6, 1994 (City Clerk Document No. RR-284038), Fourth Amendment on May 16, 1995 (City Clerk Document No. RR-285794), Fifth Amendment on June 8, 1998 (City Clerk Document No. OO-18526), Sixth Amendment on June 14, 2003 (City Clerk Document No. OO-19195), Seventh Amendment on May 30, 2008 (City Clerk Document No. OO-19761), and Eighth Amendment on June 27, 2013 (City Clerk Document No. RR-308296); and

WHEREAS, the City and MTS now desire to enter into a Ninth Amendment for Administration of Taxicab and Other For-Hire Vehicle Regulation; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:


Section 1. That the Mayor, or his designee, is hereby authorized to execute, for and on behalf of said City, the Ninth Amendment to the Agreement with Metropolitan Transit System (MTS) for administration of taxicab and other for-hire vehicle regulations, the under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No.

OO- 20371 together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the Mayor shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

Section 2. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.


