

ORDINANCE NUMBER O- 20381 (NEW SERIES)

DATE OF FINAL PASSAGE JUL 17 2014

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING CHANGE ORDER NO. 2 TO THE AGREEMENT WITH HABITAT WEST, INC. FOR HABITAT RESTORATION AND MAINTENANCE WORK AS PART OF THE CANYON VIEW UPLAND MITIGATION PROJECT.

WHEREAS, on September 19, 2011, the City of San Diego (City) entered into an agreement with Habitat West, Inc. (Habitat West), in the amount of \$686,807.01, for the Canyon View Upland Mitigation Project (Project), which Project includes the restoration of approximately 0.9 acre of native grassland and 6.79 acres of coastal sage scrub habitat, within the Los Penasquitos Canyon Preserve east of Black Mountain Road, south of Adolphia Street and north of Mercy Road; and

WHEREAS, the Project is currently in year 2 of the required 5-year maintenance and monitoring period and requires a time extension to authorize the full five years of maintenance and monitoring; and

WHEREAS, the City and Habitat West executed Change Order No. 1 on August 12, 2013, which authorized maintenance year 2 and extended the contract date to July 24, 2014 at no additional cost; and

WHEREAS, this Contract Change Order No. 2 is for a "NO COST" time extension of 1,195 days and will enable Habitat West to continue to provide maintenance and monitoring services for the Project through the end of the fifth year as required by the regulatory permit; and

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:


Section 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, Contract Change Order No. 2 to the aforementioned agreement with Habitat West, a copy of which is on file in the Office of the City Clerk as Document No. OO- 20381, providing for a no cost time extension of 1,195 calendar days from the expiration date of the existing contract.

Section 2. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.




