AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO TO AUTHORIZE THE SECOND AMENDMENT TO AGREEMENT WITH AECOM TECHNICAL SERVICES, INC. FOR AS-NEEDED FACILITIES BENEFIT ASSESSMENT PROJECT AUDITS AND COST VERIFICATION REVIEW; WAIVERS OF SDMC SECTION 22.3202 AND COUNCIL POLICY 300-07

WHEREAS, on October 28, 2009, AECOM Technical Services, Inc. (AECOM) was selected from a competitive interview panel to provide specialized engineering cost verification reviews on an as-needed basis; and

WHEREAS, the City of San Diego (City) and AECOM entered into an Agreement for As-needed Consultant Services for As-needed Facilities Benefit Assessment Project Audits & Cost Verification Review (Contract No. H094792) dated July 9, 2010; and

WHEREAS, the City and AECOM entered into the First Amendment Agreement, which is on file in the Office of the City Clerk as Document No. RR-307447, to increase the contract amount from \$250,000 to \$750,000, and to provide additional as-needed consultant services; and

WHEREAS, the City requires additional services to complete a number of project reviews currently in process and to increase the contract amount from \$750,000 to \$1,750,000; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is authorized to execute the Second Amendment to Agreement by and between the City and AECOM Technical Services Inc., in an amount not to exceed \$1,750,000, which is on file in the Office of the City Clerk as Document

No. <u>OO - 20393</u> (Agreement), under the terms and conditions set forth in the Agreement.

Section 2. That San Diego Municipal Code section 22.3202 and Council Policy 300-07, Consultant Services Selection, are hereby waived with respect to AECOM and the Agreement.

Section 3. That the Chief Financial Officer is authorized to expend an amount not to exceed \$1,750,000 solely and exclusively for the purpose of providing funds for the above Agreement, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
