AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE SECOND AMENDMENT TO THE AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND PLATT/WHITELAW ARCHITECTS, INC. FOR AS-NEEDED ARCHITECTURAL DESIGN SERVICES FOR VARIOUS CAPITAL IMPROVEMENT PROJECTS.

WHEREAS, on September 1, 2009, the City of San Diego [City] entered into an agreement between the City and Platt/Whitelaw Architects, Inc. [Agreement], to provide As-Needed Architectural Design Services for various Capital Improvement Projects; and

WHEREAS, on September 19, 2012, the Agreement was amended [First Amendment] to extend the duration of the Agreement by an additional 24 months, bringing the total Agreement duration to 60 months (five years); and

WHEREAS, under the Agreement and First Amendment a total of 52 task orders have been issued, of which 22 of them are still in process and need additional time beyond the originally authorized five years to complete them; and

WHEREAS, the City would like to amend the Agreement again [Second Amendment] to extend the Agreement by an additional 36 months (three years) to ensure enough time to complete the outstanding task orders; and

WHEREAS, during the execution of one of the task orders, Chollas Yard, Platt/Whitelaw ran into unforeseen conditions that will require additional design services on that task order, the Second Amendment will add an amount not to exceed Two Hundred Thousand dollars (\$200,000) to the Agreement to compensate Platt/Whitelaw Architects, Inc. for those additional services; and

WHEREAS, the Second Amendment will extend the total term of the Agreement beyond five Years; and

WHEREAS, under San Diego Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by ordinance adopted by a two-thirds' majority vote of the City Council; NOW, THEREFORE;

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is hereby authorized to execute, for and on behalf of said City, the Second Amendment to the As-Needed Architectural Design Services Agreement with Whitelaw/Platt Architects, Inc. to extend the duration of the Agreement by an additional 36 months (three years) and add an amount not to exceed Two Hundred Thousand dollars (\$200,000) to the Agreement for the purpose of completing the open task orders for various Capital Improvement Projects under the terms and conditions set forth in the Second Amendment on file in the Office of the City Clerk as Document No. OO-___20395, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the Mayor shall deem necessary from time to time in order to carry out the purposes and intent of this Project and Agreement.

Section 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$200,000 over the additional three years, contingent upon the adoption of the of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for this expenditure are, or will be, on deposit in the City Treasurer.

Section 3. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
