AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A NO COST SECOND AMENDMENT AGREEMENT WITH GEOSYNTEC CONSULTANTS.

WHEREAS, in July 2009, City Council approved an agreement with Geosyntec Consultants by Resolution No R-304951 for the Alta La Jolla Drainage Phase II Repair Project (Project), and the Mayor subsequently authorized a First Amendment to the agreement; and

WHEREAS, Geosyntec has prepared a design for the Project that was submitted for regulatory review and permits from the United States Army Corps of Engineers, San Diego Regional Water Quality Control Board, and California Fish and Wildlife Service; and

WHEREAS the Project has applied for and received conditional permits from the regulatory agencies; and

WHEREAS, the design of the project must now be conformed to the permits and extended monitoring performed according to the Project's mitigation measures; and

WHEREAS, due to the need for continuing consultant services the City wishes to extend the Agreement to July 2021;

NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is authorized to execute, for and on behalf of said City, a Second Amendment to an agreement with Geosyntec Consultants to complete Phase II of the Alta La Jolla Alta Drainage Repair Project, under the terms and conditions set forth in the Second Amendment, on file in the Office of the City Clerk as Document No. OO-20398

Section 2. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
