DATE OF FINAL PASSAGE AUG 08 2014

AN ORDINANCE OF THE COUNCIL OF THE CITY OF  
SAN DIEGO EXEMPTING TWO MAYOR REPRESENTATIVE  
II POSITIONS IN THE OFFICE OF THE MAYOR FROM THE  
CLASSIFIED SERVICE OF THE CITY OF SAN DIEGO.

WHEREAS, on July 3, 2014, the City of San Diego (City)'s Civil Service Commission reviewed a request from the Office of the Mayor (Department) to exempt two Mayor Representative II positions from the Classified Service; and

WHEREAS, the Mayor Representative II positions will be responsible for reviewing and recommending changes to City policies and programs under the authority of the Mayor; and

WHEREAS, San Diego Charter (Charter) section 117(a)(17) states that the Unclassified Service shall include "[m]anagerial employees having significant responsibilities for formulating or administering departmental policies and programs. Each such position shall be exempted from the Classified Service by ordinance, upon the initiation of the appropriate appointing authority and after receiving the advisory review and comment of the Civil Service Commission and the approval of the City Council"; and

WHEREAS, on July 3, 2014, upon review of the duties and responsibilities of two Mayor Representative II positions, as provided by the Department, the Civil Service Commission determined that the two Mayor Representative II positions meet the standard set forth in Charter section 117(a)(17) to be placed in the Unclassified Service; and

WHEREAS, the determination of the Civil Service Commission is set forth in a Memorandum dated July 7, 2014, from Hadi Dehghani, Personnel Director, to the Honorable Council President and City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:


Section 1. That the Council has received and reviewed a Memorandum from Personnel Director Hadi Dehghani, dated July 7, 2014, which documents that, on July 3, 2014, the City's Civil Service Commission reviewed and favorably commented on a proposal from the Office of the Mayor to exempt from the City's Classified Service two Mayor Representative II positions, in the Office of the Mayor, who will be responsible for reviewing and recommending changes to City policies and programs under the authority of the Mayor.

Section 2. That pursuant to Charter section 117(a)(17), with the Civil Service Commission's review and approval, the Council now exempts from the Classified Service and declares to be in the Unclassified Service of the City two Mayor Representative II positions in the Office of the Mayor, performing the duties set forth in the July 7, 2014, Memorandum from Personnel Director Hadi Dehghani to the Honorable Council President and City Council.

Section 3. That a full reading of this Ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 4. That this Ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
