DATE OF FINAL PASSAGE OCT 14 2014

AN ORDINANCE OF THE COUNCIL OF THE CITY
OF SAN DIEGO AUTHORIZING TO EXECUTE THE SECOND
AMENDMENT TO THE AGREEMENT WITH DOMINY +
ASSOCIATES LLP, FOR THE MISSION BEACH LIFEGUARD
STATION PROJECT.

WHEREAS, South Mission Beach Lifeguard Station (Project) is located at 700 North
Jetty Road, Mission Bay Park; and

WHEREAS, the existing facility was built in the 1970's as a temporary lifeguard tower
and now it is old, undersized, deteriorated and no longer serves the needs of the lifeguard staff
nor the public; and

WHEREAS, on January 25, 2011, the First Amendment was approved by City Council to
provide professional design services for the South Mission Beach Lifeguard Station; and

WHEREAS, Dominy & Associates was selected in accordance with Council Policy 300-
7, and entered into an agreement with the City of San Diego on September 24, 2003, as
Document No. C-12257; and

WHEREAS, the proposed Second Amendment to the Agreement with Dominy +
Associates Architects will re-design a new facility to incorporate new design standards for
Lifeguard Stations; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of
said City, the Second Amendment to an agreement with Dominy + Associates for the purpose of
completing the design of the Project, under the terms and conditions set forth in the Agreement
on file in the Office of the City Clerk as Document No. OO- 20414

Section 2. That the expenditure of an amount not to exceed \$98,000 from CIP S-00791, South Mission Beach Lifeguard Station, Fund 4008-48, Def Maint 2012A-Proj. is authorized for the purpose of providing funds for the above-referenced Project.


Section 3. That the Chief Financial Officer, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

Section 4. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 5. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
