DATE OF FINAL PASSAGE OCT 14 2014

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF THE FIRST AMENDMENT TO THE AGREEMENT WITH AECOM TECHNICAL SERVICES, INC. FOR THE INTERSTATE 5/SORRENTO VALLEY ROAD INTERCHANGE IMPROVEMENTS IN THE TORREY PINES/TORREY HILLS COMMUNITY PLAN AREA.

WHEREAS, on August 6, 2008, the City Council approved approximately \$2,996,750 of financing for developing three of the twelve potential alternatives shown in the preliminary study to improve the Interstate 5/Sorrento Valley Road interchange; and

WHEREAS, AECOM Technical Services, Inc. was selected in accordance with Council Policy 300-7, and entered into an Agreement with the City of San Diego on August 6, 2008, as Resolution No. R-304010; and

WHEREAS, the proposed First Amendment to the Agreement with AECOM Technical Services, Inc. is required to extend the contract time in order for the consultant to complete the final commitments required by Caltrans for the two project alternatives at no additional cost to the City; NOW, THEREFORE,


BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor is hereby authorized and empowered to execute, for and on behalf of said City, the First Amendment to an Agreement with AECOM Technical Services, Inc. for the purpose of extending the contract for up to an additional 5 years at no additional cost to the City.

Section 2. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.


