AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO EXEMPTING CERTAIN UTILITIES UNDERGROUNDING PROGRAM PROJECTS FROM STREET RESURFACING AND SLURRY SEALING CONSTRUCTION MORATORIUMS.

WHEREAS, the City adopted the Street Preservation Ordinance (SPO), effective on February 1, 2013, which amended the San Diego Municipal Code regarding excavations within the public right-of-way; and

WHEREAS, the SPO extended moratoriums on excavations on streets that had been recently resurfaced or slurry sealed without a valid waiver from the City Engineer; and

WHEREAS, the SPO set out conditions under which the City Engineer may grant a waiver to the excavation moratoriums; and

WHEREAS, the SPO did not include waiver grounds for City Utilities Undergrounding Program projects that were planned but became in conflict with the extended excavation moratoriums imposed by the SPO; and

WHEREAS, the City desires that certain City Utilities Undergrounding Program projects, as described in Exhibit A, be exempt from San Diego Municipal Code § 62.1206, Moratorium Streets; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Utilities Undergrounding Program projects described in Exhibit A, on file in the Office of the City Clerk as Document No. OO ______, are exempt from San Diego Municipal Code § 62.1206.

Section 2. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
