DATE OF FINAL PASSAGE OCT 28 2014

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXTENSION OF THE JOINT USE AGREEMENT FOR WEGEFORTH ELEMENTARY SCHOOL TO PROVIDE FOR THE CONSTRUCTION, OPERATION, AND MAINTENANCE OF A TURF FIELD AND RECREATIONAL FACILITIES PAST FIVE YEARS.

WHEREAS, Wegeforth Elementary School is located at 3443 Ediwhar Ave, in the Serra Mesa Community Planning Area and the terms for the Agreement will allow for the construction, operation and maintenance of approximately 3.26 acres of turfed fields, associated infrastructure, and one comfort station facility; and

WHEREAS, the proposed facilities at Wegeforth Elementary School will be developed by the City of San Diego and the joint-use field will be maintained pursuant to this Agreement with the San Diego Unified School District (District); and

WHEREAS, the City and District desire to establish this mutually beneficial Agreement for a twenty-five (25) year time period; and

WHEREAS, the City and District have been cooperating in the use of numerous recreational facilities in accordance with the City-District Recreation agreement of September 1948, and the Memorandum of Understanding (MOU) between the City and District for the Development and Maintenance of Joint Use Facilities, adopted by San Diego Resolution R-297149 (Oct. 7, 2002) and by the District's Board of Education on October 8, 2002; and

WHEREAS, the District's Board of Education approved this joint use agreement for Wegeforth Elementary School on June 24, 2014; and

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:


Section 1. That the Mayor, or his designee, is authorized to introduce the ordinance to execute, for and on behalf of said City, the lease and joint-use agreement between the City and the San Diego Unified School District for the construction, operation, and maintenance of a turf field and recreational facilities at Wegeforth Elementary School (Agreement), under the terms and conditions set forth in the Agreement, on file in the Office of the City Clerk as Document No. OO 20420.

Section 2. That the Chief Financial Officer, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

Section 3. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.


