DATE OF FINAL PASSAGE

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF THE SECOND AMENDMENT TO THE AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND NADEL ARCHITECTS, INC. FOR THE DESIGN OF THE TEMPORARY AND PERMANENT FIRE STATION NO. 22.

WHEREAS, Fire Station No. 22 is a 67 year old facility servicing the Point Loma area; and

WHEREAS, on March 2, 2004, the City of San Diego (City), entered into an agreement with Nadel Architects, Inc. (Agreement), to provide Architectural Design Services for the demolition and replacement of Fire Station No. 22 (Project); and

WHEREAS, on November 19, 2010, the Agreement was amended (First Amendment) adding funds to update the plans to the current building code requirements, meet LEED requirements, and bring the plans to 100% completion; and

WHEREAS, prior to demolition of the current station and the start of construction of the new permanent fire station, there will be a need for a temporary facility to ensure continuity of fire response services in that area; and

WHEREAS, the City would like to amend the Agreement again (Second Amendment) adding \$150,000 to the Agreement, to cover additional scope that will include the design of the temporary fire station, as well as construction administration services for the entire Project; and

WHEREAS, the Second Amendment will extend the total term of the Agreement beyond five years; and

WHEREAS, under San Diego charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by ordinance adopted by a two-thirds' majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is hereby authorized to execute, for and on behalf of said City, the Second Amendment to the Agreement with Nadel Architects, Inc. for the purpose of designing the temporary station and completing the Project under the terms and conditions set forth in the Second Amendment on file in the Office of the City Clerk as Document No. OO- 20421, together with any reasonably necessary modifications or amendments thereto which do not increase Project scope or cost and which the Mayor shall deem necessary from time to time in order to carry out the purposes and intent of this Project and Agreement.

Section 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$150,000 from CIP S-00787, Fire Station No. 22 Project, Fund 400848, Deferred Maintenance 2012A- Project, for the purpose of executing the Second Amendment, contingent upon the Chief Financial Officer first demonstrating funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

Section 3. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
