DATE OF FINAL PASSAGE OCT 28 2014

AN ORDINANCE OF THE COUNCIL OF THE CITY OF
SAN DIEGO EXEMPTING ONE PROGRAM MANAGER
POSITION IN THE ECONOMIC DEVELOPMENT
DEPARTMENT FROM THE CLASSIFIED SERVICE.

WHEREAS, on August 4, 2014, the City of San Diego (City)'s Civil Service Commission reviewed a request from the Economic Development Department (Department) to exempt one Program Manager position from the Classified Service; and

WHEREAS, the Program Manager will introduce, oversee, and implement the City's Climate Change Action Plan and related mobility, energy efficiency, and conservation initiatives; and

WHEREAS, the Program Manager will recommend policy and procedural changes; promote and foster the industry by supporting company retention, expansion, and trade development; and support entrepreneurs and startups; and

WHEREAS, San Diego Charter (Charter) section 117(a)(17) states that the Unclassified Service shall include "[m]anagerial employees having significant responsibilities for formulating or administering departmental policies and programs. Each such position shall be exempted from the Classified Service by ordinance, upon the initiation of the appropriate appointing authority and after receiving the advisory review and comment of the Civil Service Commission and the approval of the City Council"; and

WHEREAS, upon review of the duties and responsibilities of the Program Manager position, as provided by the Department, the Civil Service Commission determined that the Program Manager position meets the standard set forth in Charter section 117(a)(17) to be placed in the Unclassified Service; and

WHEREAS, the finding of the Civil Service Commission is set forth in a memorandum dated August 7, 2014, from Hadi Dehghani, Personnel Director, to the Honorable Council President and City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Council has received and reviewed a Memorandum from Personnel Director Hadi Dehghani, dated August 7, 2014, which documents that, on August 4, 2014, the City's Civil Service Commission reviewed and favorably commented on a proposal from the Department to exempt from the City's Classified Service one Program Manager position in the Department. The Program Manager will introduce, oversee, and implement the City's Climate Change Action Plan and related mobility, energy efficiency, and conservation initiatives. The Program Manager will also recommend policy and procedural changes; promote and foster the industry by supporting company retention, expansion, and trade development; and support entrepreneurs and startups.

Section 2. That pursuant to Charter section 117(a)(17), with the Civil Service Commission's review and approval, the Council now exempts from the Classified Service and declares to be in the Unclassified Service of the City one Program Manager position in the Economic Development Department, performing the duties set forth in the August 7, 2014, Memorandum from Personnel Director Hadi Dehghani to the Honorable Council President and City Council.

Section 3. That a full reading of this Ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 4. That this Ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
