AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO TO AUTHORIZE A PARTNERS FOR FISH AND WILDLIFE PROGRAM LANDOWNER AGREEMENT WITH THE UNITED STATES FISH AND WILDLIFE SERVICE AND GROUNDWORK SAN DIEGO-CHOLLAS CREEK FOR A HABITAT IMPROVEMENT PROJECT AT CHOLLAS RADIO CANYON.

WHEREAS, the United States Fish and Wildlife Service (Service) has awarded funds to Goundwork San Diego-Chollas Creek for a habitat restoration and revegetation project located at the Chollas Radio Canyon within the Multi-Habitat Planning Area (MHPA) of the City's Multiple Species Conservation Program (MSCP) Subarea Plan; and

WHEREAS, the Service requires an agreement to be signed by the City of San Diego, the organization awarded the project funding, and the Service for the financial or material support of the project by the City and to authorize the Service to enter the land for habitat management and to inspect completed work on the project; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is authorized and directed to execute, for and on behalf of the City, the Partners for Fish and Wildlife Program Landowner Agreement with the United States Fish and Wildlife Service and Groundwork San Diego-Chollas Creek, on file with the Office of the City Clerk as Document No. OO- 20424, for the habitat restoration and revegetation project located at the Chollas Radio Canyon.

Section 2. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
