AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO TO AUTHORIZE A PARTNERS FOR FISH AND WILDLIFE AND COASTAL PROGRAM LANDOWNER AGREEMENT WITH THE UNITED STATES FISH AND WILDLIFE SERVICE AND CHAPARRAL LANDS CONSERVANCY FOR A HABITAT IMPROVEMENT PROJECT AT CARMEL MOUNTAIN PRESERVE AND PROCTOR VALLEY.

WHEREAS, the United States Fish and Wildlife Service (Service) has awarded funds to the Chaparral Lands Conservancy for a habitat restoration and revegetation project located at the Carmel Mountain Preserve and Proctor Valley within the Multi-Habitat Planning Area (MHPA) of the City's Multiple Species Conservation Program (MSCP) Subarea Plan; and

WHEREAS, the Service requires an agreement to be signed by the City, the organization awarded the project funding, and the Service for the financial or material support of the project by the City and to authorize the Service to enter the land for habitat management and to inspect completed work on the project; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 2. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
