AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF THE SECOND AMENDMENT TO THE AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND MANUEL ONCINA ARCHITECTS FOR AS-NEEDED ARCHITECTURAL DESIGN SERVICES FOR VARIOUS CAPITAL IMPROVEMENTS PROJECTS.

WHEREAS, on December 4, 2009, the City of San Diego (City) entered into an agreement with Manuel Oncina Architects (Agreement), to provide As-Needed Architectural Design Services for various Capital Improvements Projects (Project); and

WHEREAS, on March 11, 2013, the Agreement was amended (First Amendment) to extend the duration of the Agreement by an additional 24 months bringing the total Agreement duration to 60 months (five years); and

WHEREAS, under the Agreement and First Amendment a total of 39 task orders have been issued, of which 13 of them are still in process and need additional time beyond the originally authorized five years to complete them; and

WHEREAS, the City would like to amend the Agreement again (Second Amendment) to extend the Agreement by an additional 36 months (three years) to ensure enough time to complete the outstanding task orders; and

WHEREAS, the Second Amendment will extend the total term of the Agreement beyond five years; and

WHEREAS, under San Diego Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by ordinance adopted by a two-thirds' majority vote of the City Council; NOW, THEREFORE;

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is hereby authorized to execute, for and on behalf of said City, the Second Amendment to the As-Needed Architectural Design Services Agreement with Manuel Oncina Architects to extend the duration of the Agreement by an additional 36 months (three years), for the purpose of completing the open task orders for various Capital Improvements Projects under the terms and conditions set forth in the Second Amendment on file in the Office of the City Clerk as Document No. OO-20428, together with any reasonably necessary modifications or amendments thereto which do not increase Project scope or cost and which the Mayor shall deem necessary from time to time in order to carry out the purposes and intent of this Project and Agreement.

Section 2. That a full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect, and be in force on the thirtieth day from and after its final passage.
