AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE FIRST AMENDMENT TO THE CONSULTANT AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND AECOM USA, INC. FOR THE MBC BIOSOLIDS STORAGE SILOS 9 & 10 PROJECT.

WHEREAS, the City of San Diego executed a consultant agreement with AECOM USA, Inc. (AECOM) for engineering design and construction support services for the MBC Biosolids Storage Silos (9 & 10) Project, CIP-S00322, a copy of which agreement is on file in the Office of the City Clerk as Document No. RR-304713 (Agreement); and

WHEREAS, unforeseen utilities conflicts resulted in project delays and increased costs, and the City seeks a time extension and increased funding for the Agreement in order to allow AECOM to continue to provide construction support services; and

WHEREAS, the First Amendment to the Agreement will extend the total term of the Agreement beyond five years; and

WHEREAS, under San Diego Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by ordinance adopted by a two-thirds' majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is authorized to execute the First Amendment to the Agreement with AECOM for additional construction support services for the MBC Biosolids Storage Silos (9 & 10) Project, CIP-S00322, in an additional amount not to exceed

\$71,323.50, for a total contract amount of \$954,556.50, contingent upon the Chief Financial Officer demonstrating that the funds are, or will be on deposit with the City Treasury.

Section 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$71,323.50 from CIP-S00322, MBC Biosolids Storage Silos (9 & 10) Project, Fund 700009, Metro Sewer CIP, for the purpose of executing this First Amendment, contingent upon adoption of the Fiscal Year 2015 Appropriation Ordinance and contingent on the Chief Financial Officer certifying that the funds are, or will be, on deposit with the City Treasury.

Section 3. That a full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been made available to the City Council and the public a day prior to its final passage.

Section 4. That this ordinance shall take effect, and be in force on the thirtieth day from and after its final passage.
