DATE OF FINAL PASSAGE DEC 12 2014

AN ORDINANCE OF THE COUNCIL OF THE CITY OF
SAN DIEGO AMENDING AND EXTENDING THE
AGREEMENT WITH DUNFORD MEDICAL CONSULTATION
FOR CITY MEDICAL DIRECTOR SERVICES.

WHEREAS, The City of San Diego's Emergency Medical Services (EMS) Medical Director Agreement (Agreement) was awarded effective January 1, 2010 after the City completed a request for proposal (RFP) process; and

WHEREAS, the Agreement had an initial term of five years, and is set to expire on December 31, 2014; and

WHEREAS, the term of the Agreement may be extended by an additional five years should the City choose to exercise that option; and

WHEREAS, the City desires to extend the Agreement and to amend the Agreement to clarify the Medical Director's scope of work regarding the oversight of the City's medical workforce; and

WHEREAS, the City EMS Medical Director plays an integral role in the City's EMS system and City programs such as Project HeartBeat; and

WHEREAS, the base compensation for this extended Agreement is \$232,040 per calendar year and includes a CPI adjustment at the start of each fiscal year of up to 3%; and

WHEREAS, the total cost for a five-year extension of the Agreement, should all of the available one-year extensions be executed, shall not exceed \$1,250,405; and

WHEREAS, these costs are currently partially offset by the City's ambulance transport fee; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is hereby authorized to execute an amended Emergency Medical Services Medical Director Agreement with Dunford Medical Consultation, extending that agreement from January 1, 2015 to December 31, 2015 with four optional one-year extensions.

Section 2. That the Chief Financial Officer is authorized to appropriate and the City Comptroller is authorized to expend the funds for the contracted services for the second half of FY 2015, in the amount of \$116,020, and for each subsequent fiscal year as part of the budget process.

Section 3: That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
