A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AUTHORIZING AND APPROVING THE  
APPOINTMENT TO THE SOLID WASTE LOCAL  
ENFORCEMENT AGENCY INDEPENDENT HEARING  
PANEL

WHEREAS, the City of San Diego was designated as its own Solid Waste Local Enforcement Agency (LEA) by the California Integrated Waste Management Board on November 19, 1997; and

WHEREAS, the LEA is charged with enforcement of state regulations as they relate to solid waste facilities; and

WHEREAS, pursuant to Public Resources Code section 44308, the City has established an independent hearing panel (LEA Hearing Panel) to conduct appeals pertaining to these state regulations; and

WHEREAS, the chairperson of the governing body, who in this case is the Council President, may appoint members of the LEA Hearing Panel; and

WHEREAS, members of the LEA Hearing Panel shall be selected for their legal, administrative, or technical abilities in areas relating to solid waste management; and

WHEREAS, the LEA Hearing Panel must include a technical expert in solid waste management and a representative of the public at large; and

WHEREAS, the Public Resources Code provides that members of the LEA Hearing Panel shall serve a term of four years and for no more than two consecutive terms; and


WHEREAS, by Resolution No. 307138, the City Council appointed Wayne Williams, Ph.D., to serve as a member of the LEA Hearing Panel in the Public At Large category with a term expiring December 4, 2015; and

WHEREAS, the Council President supports the continued appointment of Mr. Williams and the appointments of Dr. Jane Teranes and Robert Mahlowitz to serve on the Solid Waste Local Enforcement Agency Independent Hearing Panel; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the appointments by the Council President of the following individuals to serve as members of the Local Enforcement Agency Hearing Panel, for the terms ending as indicated and in the categories indicated, be and the same are hereby confirmed.


