A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO VACATING WATER UTILITY EASEMENTS LOCATED AT 333 WEST HARBOR DRIVE (EASEMENT VACATIONS NOS. 949819, 949818, AND 949816, PROJECT NO. 270201).

WHEREAS, California Streets and Highways Code section 8320 *et seq.* and San Diego Municipal Code section 125.1001 *et seq.* provide a procedure for the vacation of public service easements by City Council resolution; and

WHEREAS, Pacific Gateway Ltd. dba San Diego Marriott Marquis & Marina, a California limited partnership (“Applicant”), filed an application to vacate water utility easements located at 333 West Harbor Drive, San Diego, CA, 92101 (“Property”) (Easement Vacation Nos. 949819, 949818, and 949816, Project No. 270201); and

WHEREAS, the Property underlying Easement Vacations Nos. 949819, 949818, and 949816 is owned by the San Diego Unified Port District, a California public corporation (“Owner”); and

WHEREAS, under Charter section 280(a)(2), this resolution is not subject to veto by the Mayor because this matter requires the City Council to act as a quasi-judicial body and where a public hearing was required by law implicating due process rights of individuals affected by the decision and where the Council was required by law to consider evidence at the hearing and to make legal findings based on the evidence presented; and

WHEREAS, on November 15, 2013, the City of San Diego, as Lead Agency, through the Development Services Department, certified that the information contained in Project No.

270201 has been completed in compliance with the California Environmental Quality Act (CEQA) and State CEQA Guidelines, and that the project is consistent with the previously adopted Addendum #1 to the San Diego Marriott Marquis and Marina Facilities Improvement Project and Port Master Plan Amendment Final Environmental Impact Report (FEIR) UPD #83356-EIR 846; SCH#2010091012 which was before the San Diego Unified Port District Board of Port Commissioners and certified on May 7, 2013 and reflects the independent judgment of the City of San Diego as Lead Agency; and

WHEREAS, the matter was set for public hearing on January 14, 2014, testimony having been heard, evidence having been submitted, and the City Council having fully considered the matter and being fully advised concerning the same; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that with respect to the vacation of Easement Nos. 949819, 949818, and 949816, Project No. 270201, the Council finds that:

(a) There is no present or prospective public use for the easement, either for the facility or purpose for which it was originally acquired or for any other public use of a like nature that can be anticipated.

The easements to be vacated were reserved by the City in 1982 for purposes of water services. The easements lie within a site that contains ongoing projects for the San Diego Marriott Marquis and Marina. There is no present or prospective public use for the easements to be vacated by this action because the easements and the associated water lines are being relocated to a different location to allow for new water lines to be constructed replacing older piping on the existing site. Therefore, the easements no longer serve any current public purpose and no future public use of the easement can be anticipated.

(b) The public will benefit from the action through improved utilization of the land made available by the vacation.

The public will benefit from the vacation of the easements because it will eliminate unnecessary and unproductive encumbrances on the property at issue. The elimination of these burdens would facilitate more productive use of the property in the future and remove any liability to the City of San Diego.

(c) The vacation is consistent with any applicable land use plan.

The vacation of the easements is consistent with the General Plan, the Downtown Community Plan, and the goals and policies of any other applicable land use plan. The vacation of the easements would facilitate the growth of the San Diego Marriott Marquis and Marina in a manner that would be harmonious with the applicable land use plans. Therefore, the easement vacations would be consistent with applicable land use plans.

(d) The public facility or purpose for which the easement was originally acquired will not be detrimentally affected by the vacation or the purpose for which the easement was acquired no longer exists.


The easements to be vacated were reserved by the City in 1982 for purposes of water services. The easements lie within a site that contains ongoing projects for the San Diego Marriott Marquis and Marina. The public service easements will be relocated to allow for new water lines to be constructed replacing older piping on the existing site. As such, the public facility for which the easements were originally acquired will not be detrimentally affected by the vacation..

BE IT FURTHER RESOLVED, that Easement Vacation Nos. 949819, 949818, and 949816, Project No. 270201, as more particularly described in the legal description marked as

Exhibit "A," and shown on Drawing Nos. 36844, 36843, 36842, marked as Exhibit "B," which are by this reference incorporated herein and made a part hereof, are ordered vacated; and

BE IT FURTHER RESOLVED that the Development Services Department shall record a certified copy of this resolution with attached exhibits, attested by the City Clerk under seal, in the office of the County Recorder.

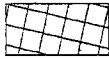

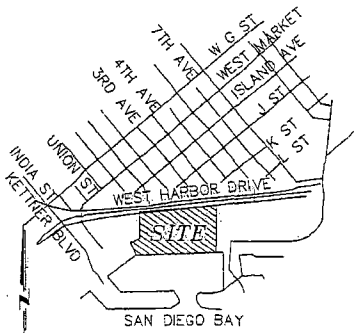
