A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AMENDING COUNCIL POLICY 000-21
ENTITLED "SUBMISSION OF BALLOT PROPOSALS."

WHEREAS, in 1995, the City Council adopted a resolution creating Council Policy No. 000-21, entitled "Submission of Ballot Proposals," which is on file with the Office of the City Clerk; and

WHEREAS, Council Policy No. 000-21 provides that proposed ballot measures be reviewed by the Rules Committee and a determination made as to whether to forward proposals to the Council; and

WHEREAS, the Council recently updated the names and duties of the Council Standing Committees and it is now necessary to revise Council Policy No. 000-21 to be consistent with those changes; and

WHEREAS, Council Policy No. 000-21 has not been amended since adoption in 1995 and it is necessary to revise the policy to conform to current City practices and procedures; and

WHEREAS, Council Policy No. 600-30 "General Plan Amendments to Shift Land from Future Urbanizing to Planned Urbanizing Area" contains procedures for submission of General Plan amendments to the voters which are outdated and can be incorporated into the revisions to Council Policy No. 000-21; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that Council Policy No. 000-21, entitled "Submission of Ballot Proposals" is revised as set forth in the Council Policy filed in the Office of the City Clerk as Document No. RR- 308730

BE IT FURTHER RESOLVED, that the City Clerk is instructed to update the Council Policy Manual to include the revised Council Policy No. 000-21.
